
Note:

1. The Candidate should also bring the following certificate, if applicable:

- (a) SC/ST Certificate issued by the competent authority (in the standard format as specified in the UG Information Bulletin 2025) and it should be in English or Hindi in language. Sub caste should be clearly mentioned in the certificate. In case the certificate is in regional language the candidate should carry an Attested translated copy of the certificate in English/ Hindi.
 - (b) OBC-NCL as per Central List certificate issued by the competent authority. The sub - caste should tally with the Central List of OBC. The OBC candidates should not belong to Creamy Layer to claim OBC reservation benefit. The OBC certificate must be in the standard format as mentioned in the UG Information Bulletin 2025.
 - (c) Disability Certificate issued from a duly constituted and authorized Medical Board by the designated centres as per NMC norms (For AIQ).
(SQ candidates should bring Certificate from State Disability Board as per NMC Guidelines 2025). No other PWD certificate, issued by any other Authority/Hospital will be entertained.
 - (d) EWS Certificate as per the prescribed format.
2. **CANDIDATES SHOULD BRING CERTIFICATES AND ALL ANNEXURES IN SUPPORT OF ALLOTTED CATEGORY ISSUED BY THE COMPETENT AUTHORITY.**
3. *Certificates issued by the competent authority on standard format, should be in English or Hindi language. Candidates are advised to carry certified (attested) Copy of English version of the original certificate, in case certificate issued is in regional language, along with original certificate.*
4. *A Softcopy (scanned copy of each document in .pdf format) to be kept ready with the candidates and to be submitted whenever required.*
5. **CANDIDATES WITHOUT ORIGINAL CERTIFICATES / DOCUMENTS SHALL NOT BE ALLOWED TO TAKE ADMISSION.**


